### What has happened so far at ETHZ


2006	Signing of Berlin Declaration on Open Access
2008	Open Access policy for ETHZ
2008	Open Access becomes mandatory for doctoral theses
2015	Signing of LERU Initiative "Christmas is Over"
Since 2016	Involvement in the National Open Access Strategy
2017	swissuniversities signs OA2020 Initiative


#### ETH Library services

- Green Road: OA repository Research Collection
- Golden Road: payment of article processing charges (APCs) at BioMed Central, SpringerOpen, PLOS, Copernicus, MDPI, Frontiers und Wiley
- Consulting on copyright issues
- Consulting on OA specifications from funding organisations
- Webinars, workshops & information events



### Some figures on OA at ETH Zurich

- **Green Road** A total of 164'400 entries in the ETH Research Collection, thereof 21'300 fully accessible full texts
- **Golden Road** About 15% of peer-reviewed journal literature published in Open Access journals
- All doctoral theses deposited in the ETH Research Collection. Approximately 70% published immediately, approximately 30% within 1-3 years

### **Current status of OA policy at ETHZ**


OA policy at ETH Zurich from 2008

- All publications accepted in a peer reviewed journal, doctoral theses and other research results should be published OA in ETH E-Collection (now: Research Collection) as soon as possible
- All researchers are encouraged to publish in a suitable Open Access journal;
  ETH Zurich will cover the publishing fees, such as APCs.



### The new OA policy

- Reasons for the revision:
  - Major developments in OA, library systems and publishing since 2008
  - Superordinate framework for Switzerland by adopting swissuniversities and SNF OA strategies
- In preparation for this: OA survey at ETH Zurich by ETH Library in 2017

### Framework of the survey

#### **OBJECTIVES**

- Widespread information about Open Access
- Find out about attitudes, experiences and expectations among ETH **Zurich Scientists**
- Launch a broader discussion
- Start implementation strategy

#### **METHODOLOGY**

- Online survey among the entire scientific staff at ETH Zurich
- Distribution of the questionnaire: www.iafob.ch
- Survey period: 1 24 February 2017
- Questionnaire takes about 15 minutes to complete

#### RESPONSIBILITY

- **Executive Board of ETH** Zurich
- ETH Library

Note: the results differ significantly according to the department, form of appointment, research years as a whole and research years at ETH Zurich.

How important is the following for you when submitting your research paper?


- Impact factor

To what extent do you agree with the following statements?


- Publishers provide key services for the dissemination of research results

### **Open Access services at ETH Library**

How important are the following aspects for an Open Access policy?


- Continued free choice of journal

Reason for publishing Open Access in the past twelve months






### Future use of Open Access journals at ETH Zurich

### **Challenges**

## Global dissemination of new knowledge and maximising the chances of young researchers without obstacles

- Controlling costs and time in the migration period (implementing OA shouldn't lead to higher costs)
- Young scientists' careers should be promoted, not jeopardised
- Different publishing cultures in the disciplines need to be treated adequately
- Different research cultures in Europe, the USA and Asia
- Development of the publishers: attractive new business models for OA?
- Future "publication world" not foreseeable; Golden Road just one of several ways
