01 Introduction - Open Access: A first step towards Open Science

A successful strategy ...

- for the researchers
- for the Higher Education Institutions
- for the community and the economy

...brings its own challenges ...

- for the research career and the researchers
- for the control of the institutional costs
- for the quality of research and its evaluation

... that have to be tackled by means of adequate framework conditions !

- coherent higher education policy
- cost transparence
- research evaluation based on content
- efficient management

02 Swiss National Strategy on Open Access

Common strategy of swissuniversities and the Swiss National Science Foundation (January 31, 2017) :

Guiding principles :

- 1. Powerful and unified approach
- 2. Support and commitment from research communities
- 3. Cost transparency and cost neutrality
- 4. Ascertaining control and diversity of the scientific production process
- 5. Revision of quality assessment system

Vision: by 2024 ...

- all scholarly publication activity in Switzerland should be Open Access
- all scholarly publications funded by public money must be freely accessible on the internet
- the Open Access landscape will consist of a mix of Open Access models

03 Implementation: The Swiss Open Access Action Plan

- Increase the Open Access rate :
 - Green Way
 - Golden Way
 - Offsetting Way

• Open Access policies :

- Recommendations of swissuniversities
- Policies of the Higher Education Institutions
- Governance :
 - Use of existing structures
 - Establish an Open Access Council

03 Implementation: The Swiss Open Access Action Plan

• Transversal measures:

- National monitoring
- Communication and sensibilisation
- Reform of the research evaluation
- Participation in international initiatives and infrastructures
- Timetable of measures:
 - short-term 2018,
 - medium-term 2018-2020,
 - long-term 2021-2024 (SNSF Swissuniversities)
- Cost calculation
- Consultation in Higher Education Institutions from 30 August to 27 September, 2017
- Additional to action plan: negociations with publishers

04 Impact on Research Evaluation and for Research Careers

A successful strategy for the researchers :

• A higher visibility

"OA articles receive 18% more citations than average" (Piwowar H, et. al. 2017. The State of OA: A large-scale analysis of the prevalence and impact of Open Access articles. doi:10.7287/peerj.preprints.3119v1)

- A faster access to research results and an increased exchange between researchers
- A new good scientific practice (cf. LERU)

04 Impact on Research Evaluation and Research Careers

Adequate framework conditions :

- Coherent higher education policy :
 - Support of the researcher community
 - Revision of the quality evaluation
- Research evaluation and promotion system based on the content and inspired by :
 - the San Francisco Declaration on Research Assessment (DORA) and
 - the Leiden Manifesto for Research Metrics
 - « Measuring research output in the humanities and social sciences » and «Research performances in the humanities and social sciences»
