1 Missed deadline of the project	Committed institutions and persons engaged to deliver and meet the objectives. Clear timelines of the project. Continuous information and knowledge sharing on the progress made. Exchange and coordination by regular online meetings and alignment meeting.	
2 Communication problems between partners	Kick-off meeting to establish personal contacts and responsibilities. Project guidelines for the step-to-step management of the project.	
3 Issues linked to/technology/connections/Internet	E-teaching platform of the project as a new iteration of the existing e-teaching model (iCorsi) in place at USI. Same infrastructure successfully used for an ad-hoc platform for the MEM Summer Summit at USI. USI e-lab has a list of successful mitigation strategies for specific technological risks.	
4 Security issues	iCorsi secured platform, accessible only through personal credentials, ensuring users' privacy. It is open source in terms of material but protected in terms of discussion and forum. Students free to discuss sensitive topics.	
5 Governments block server and website	Make recorded classes video available using specific dedicated tools.	
6 Unavailability of recorded classes	E-teaching courses would then mainly be based on the classes recorded during the workshops. Others recorded classes prepared by junior academics trained during the workshops. Classes recorded during existing BA and MA programs in the partner universities might be available.
